Other Information

- Our subscription for our Journey's Elementary English Language Arts curriculum is due for renewal. The curriculum was purchased several years ago, I believe in 2017, with a multi-year subscription to online materials/workbooks. It is due for renewal, and you will see we have two options, a 1-year and 3-year renewal. I am wanting to approve the 3-year as the price compared to the 1-year renewal; it would be a substantial savings. It is over my \$5000.00 limit, so it is an action item on the agenda.
- Annual Chromebook purchase. We have our quote from Applied Connective. They are local and served us well last year. This will be an action item on the agenda, and we will be using REAP Grant funds for this purchase.
- The activities directors and coaches have been meeting with uniform vendors to continue with the selection of uniforms. Football uniforms have been selected, and the quote is included in the packet; the purchase of the uniforms is on the agenda as an action item.
- We are currently looking at replacing some calculus books and science books for the 2024-2025 school year. This is not new curriculum, but replacement books. Mrs. Tenski has also been talking with Hailey Osantowski regarding some FCS materials. I am planning to use ESSER III Funds for these materials. We would also be able to use CTE funds for FCS purchases.
